For the moving of any building or structure the fee shall be \$100.00

DEMOLITION FEES

For the demolition of any building or structures, the fee shall be [Requires a \$100 cash bond]	
0 – 100,000 cu ft	\$75.00
100,001 cu ft and over	\$0.08/1,000 cu ft

PENALTIES

Any person who commences work requiring a permit on a building, structure, electrical, gas, mechanical or plumbing system before obtaining the necessary permits shall be subject to a penalty fee that is doubled the cost of the permit.

GAS PERMIT FEES

INITIAL FEE

For issuing each permit.....\$ 45.00

Pre-Inspection/Missed Inspection / Re-Inspection\$ 45.00

Gap Tap.....\$200.00

The total fees for inspection of consumers’ gas piping at one location (including both rough and final piping inspection) shall be \$5.00 for one to four outlets, inclusive, and \$1.00 for each additional outlet.

The fees for inspecting conversion burners, floor furnaces, incinerators, boilers, or central heating or air conditioning units shall be \$5.00 for one unit and \$1.00 for each additional unit.

The fee for inspecting vented wall furnaces and water heaters shall be \$2.50 for one unit and \$1.00 for each additional unit.

If any person commences any work before obtaining the necessary permit and inspection, fees shall be doubled.

MECHANICAL PERMIT FEES

INITIAL FEE

For issuing each permit.....	\$45.00
Pre-Inspection/Missed Inspection / Re-Inspection	\$45.00

Fee for inspecting heating, ventilating, ductwork, air-conditioning, hood suppression systems and refrigeration systems shall be **\$15** for the first \$1,000.00, or fraction thereof, of valuation of the installation plus \$2 for each additional \$1,000.00 or fraction thereof.

Fee for inspecting repairs, alterations and additions to an existing system shall be **\$10** plus \$2 for each additional \$1,000.00 or fraction thereof.

Fee for inspecting boilers (based upon BTU input):

33,000 Btu (1BHp) to 165,000 (5 Bhp)	\$5.00
165,001 Btu (5 Bhp) to 330,000 (10 Bhp)	10.00
300,001 Btu (10 Bhp) to 1,165,000 (52 Bhp)	15.00
1,165,001 Btu (52 Bhp) to 3,300,000 (98 Bhp)	25.00
Over 3,300,000 Btu.....	35.00

RE-INSPECTION

In case it becomes necessary to make a re-inspection of heating, ventilation, air conditioning or refrigeration system, or boiler installation, the installer of such equipment shall pay a re-inspection fee of \$45.00

TEMPORARY OPERATION INSPECTION FEE

When preliminary inspection is requested for purposes of permitting temporary operation of a heating, ventilation, refrigeration, or air conditioning system, or portion thereof, a fee of \$45.00 shall be paid by the contractor requesting such preliminary inspection. If the system is not approved for temporary operation on the first preliminary inspection, the usual re-inspection fee shall be charged for each subsequent preliminary inspection for such purpose.

SELF CONTAINED UNITS LESS THAN TWO TONS

In all buildings, except one and two family dwellings, where self-contained air conditioning units of less than two tons are to be installed, the fee charged shall be that for the total cost of all units combined.
