

## Tax Rebate Requirements and Special Websites

1. Homeowner must have resided full time in residence in 2020 inside Moultrie city limits according to GA CODE(\$21-2-217).
2. Homeowner must have turned at least 65 during 2020.
3. Homeowner must have paid 2020 property taxes IN FULL.
4. Homeowner must provide official government ID (Birth Certificate, Driver’s License, or other state or federal ID), 2020 Property tax receipt, and Homestead exemption documentation.
5. How do I sign up for Homestead Exemption if I have not already? You can visit the Colquitt County Tax Assessors office located in the Courthouse Annex building to apply for an exemption. You can find the application online here <https://qpublic.net/ga/colquitt/exemptions.html#homestead>.

If you sign up now for Homestead, we will consider that.
