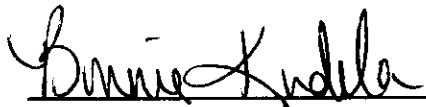
City Manager Dillard spoke on the excess of violent crime lately and stated that he and Chief Ladson had discussed a plan to combat it.

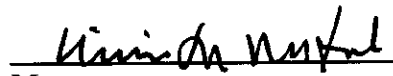
