SEALED PROPOSALS FOR 2ND ST. & TALLOKAS SE ROUNDABOUT will be received by the City of Moultrie, Georgia, until 2:00 PM, Tuesday, April 30, 2024, at the Downtown Moultrie Welcome Center, 31 East Central Ave., Moultrie, Georgia. At that time, the proposals shall be publicly opened and read. No bid submitted may be withdrawn for a period of thirty (30) days.

THE WORK TO BE DONE consists of furnishing all labor, tools, materials, and equipment necessary to construct the **2nd St & Tallokas SE Roundabout**, as shown on the plans. More specifically, the work consists of demolition and removal of concrete and asphalt. The proposed improvements will consist of installing storm pipe, curb & gutter, directional boring underground conduit, 6" water main, hydrant relocation, concrete flatwork, basing, milling, paving, and all other appurtenances necessary to complete the project in accordance with the specifications and construction drawings.

***NOTICE: A MANDATORY Pre-Bid Conference for this project will be held at 2:00 PM, local time, Tuesday, April 16, 2024, at the Downtown Moultrie Welcome Center, 31 East Central Ave., Moultrie, Georgia. Representatives of the Owner and Engineer will be present to discuss the Project. Bidders are required to attend and participate in the conference. The engineer will transmit to all prospective bidders of record such addenda as the engineer considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective. Companies, individuals, and entities that fail to attend the mandatory pre-bid conference shall not be allowed to submit a bid for the Project.**
